AUTHENTICATION OF LEGAL DOCUMENTS

Requirements/Instructions for Authentication of Legal Documents (Affidavit, Power of Attorney, Certification, etc.)

- 1. Document shall be signed in the presence of the consular officer by the person(s) executing or making the declaration(s) in the document. Executor(s) must submit, for every legal document being executed, an extra copy of the document, 2 photocopies of their identification cards showing their photo & complete name (as shown in their document/s) along with the fee as discussed in item no. 3 below.
- 2. If the person(s) cannot appear before the consular officer, the following procedures shall be observed:
 - a. The document(s) must be notarized by a Notary Public (with valid license);
 - b. The signature of Notary Public shall, in turn, be authenticated as follows:
 - If the Notary Public is a lawyer, his/her signature shall be authenticated by the Law Society of the province where the Notary Public resides;
 - If the Notary Public is not a lawyer, his/her signature shall be authenticated by the Society of Notaries Public of the province where the Notary Public resides;
 - If none of the abovementioned societies exists, the signature of the Notary Public shall be authenticated by the Office of the Lieutenant Governor of the Province.
