### **Survey on Filipino/Permanent Residents Who Wish to Travel to the Philippines**

In view of the increasing number of Filipinos and Permanent Residents who have expressed their desire to travel to the Philippines, the Philippine Consulate General in Vancouver is conducting a survey of those who would like to urgently return to the country.

In accomplishing the form, the Consulate invites attention to the conditions for travel to the Philippines, which are stated in the said form.

The conduct of the survey does not guarantee the availability of special flight/s. This will depend on the willingness of the airlines to fly and the approval of the relevant authorities, and will be subject to existing Covid-19 restrictions. The survey results, however, will serve as a basis for the Consulate General's recommendation to Manila.

- 3) The cost of the quarantine accommodation will also be borne by me, if required to pay;
- 4) Availability of flights to and from the Philippines are subject to periodic assessment and, thus, can be cancelled anytime; and
- 5) This form is being required to be submitted for purposes of assessing the need for special flights to the Philippines and recommending the same to concerned Philippine authorities and does not bind the Consulate to any commitment to this effect.
