**Requirements:**

1. **Three (3) passport-size photographs** (3.5cm x 4.5cm, full front view with white background)
2. Old Philippine passport or documents evidencing Philippine citizenship with photocopy of data page
3. Copy of travel itinerary or airline tickets
4. Fee of C\$43.50 payable in cash, certified cheque or postal money order to the Philippine Consulate General
5. Copy of proof of immigration status in Canada (e.g. PR card, work permit, visa etc.)
6. Copy of deportation/removal order, if applicable
7. Supporting documents (e.g. Death Certificate, Medical Certificate, etc.)

**Note:** (1) A travel document may be applied only for emergency reasons or urgent cases and should not be used for convenience in order to avoid going through the passport renewal process; (2) It has A Travel Document is of limited validity and must be used for direct travel to the Philippines within 30 days from the date issued.
